

**Lauren Lessing** became the director of the UI Stanley Museum of Art in July 2018. Her experience includes many years working in art museums, including the Art Institute of Chicago, the Nelson-Atkins Museum of Art in Kansas City, and the Colby College Museum of Art in Waterville, Maine, where she built the education department and created a host of innovative educational programs. Her parents—both artists—were students of the UI museum's first director, Ulfert Wilke, and she has loved the UI and Iowa City since her first visit here in 2002. Lessing has shaped an ambitious vision that includes a mission to transform lives by connecting the UI community, Iowans, and the world with extraordinary works of art. A native Midwesterner, Lessing earned a B.A. in fine art at Earlham College and completed her Ph.D. in art history at Indiana University under the guidance of Sarah Burns. She has curated exhibitions and authored many books, articles, and catalogue essays on various topics in American art.

# **Emeritus Faculty Council Lecture**

### Unpacking the Proposed "Right to Keep and Bear Arms" Amendment

Patricia M. Zebrowski, Professor Emerita, Communication **Sciences and Disorders**

On November 8, 2022, Iowans will vote on the addition of an amendment Patricia M. Zebrowski to the state constitution. The "Right to Keep and Bear Arms" amendment uses language that goes beyond the protections laid out in the U.S. Constitution's Second Amendment.



Specifically, the measure on the ballot will read: "The right of the people to keep and bear arms shall not be infringed. The sovereign state of Iowa affirms and recognizes this right to be a fundamental individual right. Any and all restrictions of this right shall be subject to strict scrutiny."

This presentation will provide an overview of Iowa's existing gun laws and their impact, along with a discussion of the so-called "strict scrutiny" provision that is a key part of the proposed ballot measure.

#### **UIRA President's Column**

# A Busy Month, a Bit of History, Changes Coming

It has been an eventful month for the UIRA. The **Program Committee** has completed scheduling the programs for this fall semester and has begun to schedule programs for next spring. I have found that the committee members are hard workers and have a great time working together—at times it's like "jocularity run wild" during the meetings. In any case, the members deserve our thanks for their creativity, dedication, and hard work.

Before describing the work of the **Board of Directors**, I need to sketch out a bit of our history. In 1995 a group of retirees received an anonymous donation of \$1,000 and a one-time contribution from the UI Foundation (now the UI Center for Advancement), and with this money the UIRA was formed. The first program offered to the members was by **Richard Saunders** from UIHR in which he presented a program about health insurance issues. Dues were \$10 each year. Since then, UIRA has funded all its programs and events through the annual dues and other volunteer monies collected from its members. Annual dues are still just \$10.

Since its formation in 1995, the UIRA has had no formal affiliation with the University of Iowa, i.e., UIRA has functions independent of the university. This situation is unique in that the UIRA is the only retirement association in the Big Ten that operates independently of its affiliated university. Furthermore, all the work of UIRA has been performed by volunteer UIRA members. Fortunately, membership has grown, and it is increasingly clear that we now need help to do the work of the association. We can no longer rely only on UIRA volunteers to keep providing meaningful programs and events for our members.

The **Board of Directors** has been working on establishing a formal connection with the University of Iowa through the President's Office and the UIHR department. We have developed a model of how this is to be accomplished, and we have drafted a version of a Memorandum of Understanding that we will make available to everyone when it has been agreed to by the university and has been approved by the Board of Directors. The central message is that there will be changes coming our way soon, and these changes will help UIRA move forward and be even more effective in providing many new opportunities and helpful information for our members. We will keep everyone informed as the process matures.

Other **UIRA committees** (Budget, Membership, Nominating, and Awards) will start their work later in the year. Participation in our committees' work can be personally satisfying. I want to again encourage everyone to consider sharing your talents, time, and interests by becoming a member of one (or more) of the UIRA committees.

### FAQ: Medicare and Health Insurance Coverage

The UI Retirees Association is again offering a Zoom session on November 3 about Making the Right Health Insurance Decision. Kevin Ward, UIRA member and Senior Health Insurance Information Program volunteer, has shared this FAQ. (The November-December issue of *The Grey Hawk* will contain additional information.)

### What are some key dates to keep in mind?

- October 15-December 7: Medicare open enrollment for Part D drug plans and publicly available Medicare Advantage plans. The university also offers an open enrollment to change among four university exclusive options: UI Choice, UI Select, Health Alliance HMO, Health Alliance PPO.
- From October 15, 2022 until March 4, 2023 is a special guaranteed enrollment period for individuals currently covered by UI Choice or UI Select to move to traditional Medicare with a "Medigap" supplement and Part D prescription drug plan. This could be particularly important for individuals with existing health conditions and/or looking for lower cost options outside the UI retiree group.

University Benefits is planning to hold a series of meetings beginning in mid-October to help provide information to UI retirees about their health insurance options. UIRA will again be offering two additional programs (see page 2).

# How often should I review my options and past decisions?

Best practice is to review your Medicare and health insurance coverage decisions annually. The university provides an open enrollment period in the fall to move between the four UI exclusive options, for coverage effective January 1. Retirees enrolled in Part D Prescription Drug Plans and the publicly available Medicare Advantage Plans may utilize the Medicare open enrollment period of October 15-December 7 each year, also effective January 1.



### Who can I talk to about my personal situation?

Senior Health Insurance Information Program (SHIIP) counselors offer individual appointments throughout the year at the Iowa City Senior Center; Mercer Recreation, North Liberty Library, as well as via phone or Zoom. ## Big Ten Retirees Association Meeting Summary

Northwestern University hosted this year's Big Ten Retirees Association meeting, August 1-3. This has been the first in-person meeting in three years. Twenty-two delegates representing 11 of the 14 institutions attended. Deb Cobb represented UIRA.

The conference features sessions on topics of common interest, as well as an opportunity to showcase the host institution. Al Tessler and David Zareski were co-chairs. Topics of the meeting included: Discussion of the new normal at our universities in the wake of COVID (including programming, virtual meetings, and technology used), creating community with your newsletter, and a fact sheet comparing the retiree organizations of member universities.

During the business meeting, the bylaws for the association and a *Conference Handbook* were reviewed and approved. Several lectures were presented by faculty at Northwestern University in various areas of expertise. Tours were provided of the Northwestern campus, the Baha'i Temple in Wilmette, and the Chicago Botanic Garden in Glencoe, Ill. A reception and dinner were held both nights, each with a featured speaker.

Northwestern University was an outstanding host and the camaraderie was much enjoyed. The 30th annual conference will be hosted by the University of Wisconsin-Madison Retirement Association, July 26-28, 2023.

### Flu and COVID Vaccines

Flu and COVID are caused by two different viruses. This year, the CDC recommends obtaining both vaccines, and it is safe to receive both (flu plus COVID vaccine; or flu plus COVID booster) at the same time. The CDC recommends obtaining your flu vaccine during September or October. Timing for the COVID booster can vary depending on timing of the vaccine or booster, so talk to your health care provider about when it is best for you to receive them.

UIRA is not offering a dedicated flu vaccine clinic this year. We recommend visiting your primary care provider, your pharmacy, or one of the Johnson County Visiting Nurse Association public clinics.
